(Revenue \$) FOR THE ZOO SOCIETY, 2020 BROUGHT UNPRECEDENTED OPERATIONAL AND FINANCIAL CHALLENGES IN MEETING OUR PROGRAM SERVICE GOALS AS WELL AS A GREAT CONCERN FOR OUR EMPLOYEES' HEALTH AND WELFARE. TYPICALLY, THE ZOO SOCIETY'S LARGEST SINGLE PROGRAM SERVICE CATEGORY, MEMBERSHIP SAW THE BIGGEST REVENUE DECLINE DUE TO THE THREE-MONTH ZOO CLOSURE AND THE CONTINUING COVID-19 ENVIRONMENT. MEMBERSHIP REVENUE WAS \$2.1 MILLION, DOWN 40% FROM 2019. MEMBERSHIPS WERE EXTENDED TO COVER THE LENGTH OF THE ZOO CLOSURE. TO KEEP MEMBERS ENGAGED AT HOME, THE ZOO SOCIETY LAUNCHED A DIGITAL AND EXPANDED Z MAGAZINE, A MONTHLY ZOONEWS 2.0 VIDEO SERIES AND DIGITAL KIDS CONTENT. (CONTINUED ON SCHEDULE O)

IN MAY 2020, THE ZOO SOCIETY COMMITTED \$800,000 IN SUPPORT OF WORK TO REIMAGINE THE 28-YEAR-OLD RAINFOREST BUILDING. THIS MONEY WAS DONOR DESIGNATED FOR THE RAINFOREST PROJECT AND WAS NOT TAKEN OUT OF POTENTIAL OPERATIONAL FUNDING FOR THE ZOO SOCIETY. THE FUNDING WAS USED FOR ARCHITECTURAL AND STRUCTURAL DRAWINGS AND ANALYSIS. IN DECEMBER 2020, THE ZOO SOCIETY COMMITTED \$500,000 IN SUPPORT OF THE METROPARKS BUILDING A ZIP LINE WITH AN ANTICIPATED OPENING DATE ON SUMMER 2021. \$250,000 OF THIS WAS A PRIVATE DONATION; \$250,000 WAS FROM BOARD-DESIGNATED RESERVES THAT CAN BE USED FOR A VARIETY OF FUNDING AS DECIDED BY A VOTE OF THE BOARD OF DIRECTORS.
