

## **Cleveland Zoological Society Animal Attractions Raffle Official Rules Page**

**Summary:** Void where prohibited. Begins January 12, 2021 and ends February 10, 2021 at 5:00 P.M. EST. Open to legal U.S. residents 18 years of age or older. Raffle ticket or admission to Animal Attractions virtual fundraiser purchase is necessary to enter. HOW TO ENTER: Promotion begins January 12, 2021 and ends February 10, 2021 at 5:00 P.M. EST (“Sweepstakes Period”). Raffle tickets may be purchased at ClevelandZooSociety.org for \$50.00 each. One raffle ticket is also included with the purchase of a \$100 admission ticket to the Cleveland Zoological Society’s virtual fundraiser, Animal Attractions, to be held on February 12, 2021 at 6:00 P.M. Ticket packages to attend the event also include raffle tickets based on package level - \$5,000.00 package includes eight raffle tickets; \$3,500.00 package includes six raffle tickets; \$2,500.00 package includes four raffle tickets’ \$1,000 package includes two raffle tickets. Cutoff dates and times to purchase are: Raffle tickets – February 10, 2021 by 5:00 P.M. EST; \$100 admission ticket – February 9, 2021 by 5:00 P.M. **Eligibility:** You must be a legal U.S. resident and 18 years of age or older to participate in the Cleveland Zoological Society’s Animal Attractions Raffle (“Sweepstakes”). All entries submitted will only be used for purposes described in the Official Rules. All entries become the exclusive property of Sponsor and will not be returned, and will not be acknowledged or returned.

**Prize:** Grand Prize: Private golf cart tour of Cleveland Metroparks Zoo for up to 4 people with Dr. Chris Kuhar, Cleveland Metroparks Zoo Executive Director and Sarah Crupi, Cleveland Zoological Society Executive Director. Grand prize package has no monetary value. Winner must be 18 years of age or older. Sponsor reserves the right to substitute a prize or prizes of substantially equal value in the event the Sweepstakes Prize becomes unavailable for any reason.

On February 12, 2021, a random drawing will be conducted by or under the supervision of Sponsor to award the Sweepstakes Prize. There will only be one winner of Sweepstakes ("Sweepstakes Prize Winner").

Odds of winning depend upon the number of entries received.

**Drawing and Notification:** Sweepstakes Prize Winner will be announced during the virtual fundraiser on February 12, 2021, and the Sweepstakes Prize Winner's name may be posted on the Cleveland Zoological Society's Facebook page. The Sweepstakes Prize Winner will also be notified by email on February 12, 2021 that he/she has been selected as the winner and given instructions regarding how to accept his/her prize.
