WE EXCEEDED OUR REVENUE GOALS FOR ANNUAL OPERATIONS INCLUDING MEMBERSHIP REVENUE OF OVER \$5 MILLION. THE ZOO SOCIETY CONTINUED DIGITAL MEMBERSHIP COMMUNICATIONS AND IN-PERSON DONOR EVENTS. IN TURN, THE ZOO SOCIETY PROVIDED \$3,023,411 IN GENERAL OPERATING SUPPORT TO CLEVELAND METROPARKS ZOO.

THAT \$1.2 MILLION THE ZOO SOCIETY PROVIDED IS COMPRISED OF \$407,194 IN SUPPORT OF ANIMAL CARE PROGRAMMING, \$164,148 IN SUPPORT OF EDUCATIONAL PROGRAMING, AND \$661,038 IN SUPPORT OF CONSERVATION PROGRAMMING.
